Discussion was held regarding the bids for the 1 ton 4 WD vehicle. Three bids were received, two being local dealers and one out-of-town dealer. The two local dealers placed the lowest bids and were within \$500 of each other. Members felt purchasing from a local dealer was important for the community. A motion was made by Mr. Kitchens, seconded by Mr. Raybion and carried 7-0 to purchase a 1 ton SRW 4-WD pickup from Heart of Texas Ford in the amount of \$33,267.41 as recommended by Mr. Clawson.

Lease Agreement w/First United **Methodist Church**

Due to internal circumstances the First United Methodist Church chose to stop operation of their pre-school on Friday, January 16, 2015. The pre-school was held in the BISD North Ward building. A lease agreement between BISD and FUMC is in effect until July 31, 2017. A motion was made by Mr. Kitchens, seconded by Mr. Lafuente and carried 7-0 to render the lease agreement between Brady ISD and First United Methodist Church null and void effective Friday, January 16, 2015 as recommended by Mr. Clawson.

February 20 **Staff Training For Testing**

Each year the district staff are required to attend a training regarding the **Noon Early Release** administering of the state standardized tests. This year the training is scheduled for Friday, February 20. A motion was made by Mr. Kitchens, seconded by Ms. Keith and carried 7-0 to release all campuses at noon on Friday, February 20, 2015 to allow the district staff to attend the required testing training.

Brady Elementary

Christy Finn, Assistant Principal reported all Benchmark testing is completed. A pilot program for 37 ESL students is underway to enhance their learning. Math TEKS have changed this year so staff is working to make the necessary accommodations. A program, TIPS, has begun which helps parents learn how to assist their student to be successful.

Middle School

Shona Moore reported the GT and Perfect Attendance groups each went on a field trip. Fairmount donated \$2,000 to the PATS organization to help purchase school supplies for all MS students. The District basketball tournament will be held February 7. MS has two robotics teams that qualified for State competition. Tutoring begins February 9. District band concert will be held January 24. Benchmark testing will be February 4 and 5. The Valentine's Dance will be February 6.

High School

Stacy Rush, Assistant Principal, stated this is the first year for HS to compete in the Robotics competition. They were proud of the students who participated. A Financial Aid meeting was held tonight at 5:30 for students and their parents. Friday at 11:07 the PALS Auction will be held and then from 6:30-8:00 that evening the PALS are hosting a spaghetti dinner. Saturday Brady is hosting a UIL Academic Meet with 7 high schools participating. The HOT Powerlift Meet will be February 12. The average attendance is 96.3%

Sarah Smith presented a budget report card comparing the past couple of years. She is looking at ways to increase breakfast sales at the MS. Explained the new "spice stations" at the campuses. There are four different spice blends that are made up of all herbs. The tower gardens are continuing with good harvests and they will be featured on the USDA website.
