Approve Funds To Purchase Band Uniforms

Kelly Rushfeldt, Band Director, stated the current band uniforms were purchased in 2007. Currently there are 120 uniforms and for this next year around 150 are needed. Upon researching available uniforms Mr. Rushfeldt reported the cost per uniform will be \$420-\$460 each for a total cost of approximately \$63,000-\$69,000. The materials used for the uniforms are lighter and more updated. Should the purchase of the uniforms be approved the Band Boosters will be included in the design and proofing of the uniforms. A motion was made by Mr. Raybion, seconded by Ms. Keith and carried 7-0 to set aside from the Fund Balance \$70,000 for the purchase of band uniforms per recommendation by Johnny Clawson, Superintendent.

Stacy Rush, Assistant Principal, reported for the 2013-2014 Accountability the high school campus met Standard rating. The UIL teams are placing well in competitions. The Ag Mechanics team built a trailer that will haul bales of hay and will enter the trailer in the San Angelo and San Antonio stock shows. This year Brady will be hosting an FFA Livestock Judging show. The Brady powerlift meet was a success with 16 different schools being represented and a total of 272 athletes participating. The daily average attendance is 96.8%.

Middle School

Russell Lee, Assistant Principal, reported all benchmark testing has been completed. Staff meetings are underway to analyze all data. District basketball tournament is completed with the 7th grade boys and the 8th grade girls being named district champions. The program Worth the Wait continues to meet. The daily average attendance is 97.96%.

Brady Elementary

Christy Finn, Assistant Principal, reported the Math TIPS, a program designed for giving tips to parents when helping their child with math had a good turnout and they hope to build in numbers. Yearbooks are on sale for \$16 each. Justin Pierce will be competing in the Regional Spelling Bee in San Angelo March 17.

Sarah Smith announced BISD was awarded a \$2,000 grant from Whole Kids Foundation. Community members are planning to donate materials to build a larger greenhouse for the tower gardens. Ms. Smith has been chosen to attend the Produce University sponsored by USDA to be held in Florida March 27.
