RANDOM DRUG TESTING REPORT The random drug testing report for April is as follows.

<u>HS</u>-39 negative tests; 5 positive tests which consisted of 1 refusal, 3 new positive testers for marijuana, and 1 new positive tester for marijuana, codeine, and morphine. This tester is also a repeat tester for marijuana and the results for the codeine and morphine are undergoing further investigation due to possible prescribed medication.

The UIL randomly selected ten Brady ISD athletes for steroid testing. All ten athletes produced negative results for steroid usage.

NEW HS CONSTRUCTION REPORT Dr. Brasher reported on two issues concerning the new high school building. The Vocational Ag building has had an ongoing odor for quite some time. Bill Baker of Waldrop Construction conducted tests trying to find where the odor is originating. Mr. Baker concluded that the ventilation system could be the cause of the odor. He will be capping off one of the vents thereby routing the ventilation system to another area of the building. Mr. Baker feels the septic tank is of adequate size for the building.

A large crack and new cracks have been found on the inside of Wing B of the new High School building seems to be widening and growing longer causing concern. Holes were drilled in the foundation and soil tested showing there is no water leakage that could be causing the crack. Mr. Baker will be sending their engineers to re-evaluate the situation and report the findings at the next regular board meeting. At this time Mr. Baker is certain it is not a structural issue. Dr. Brasher is to set an appointment with Waldrop Construction for the evaluation.
