**District & Campus** Mr. Clawson explained the District Improvement Plan is comprised of **Improvement Plans** information from each of the Campus Improvement Plans. The following

information are some of the changes on the campus level that effected the District

Improvement Plan.

## High School

Eric Bierman, Principal, stated at this time three teachers are not highly qualified but they have taken the necessary tests in order to be so. They are looking to improve attendance with possible incentives and to also get the entire staff involved in getting the parents more involved. He also stated areas of concern that need improvement is increasing the Special Education math scores and the STAAR writing scores.

### Middle School

Shona Moore, Principal, stated some programs that were not in the Campus Improvement Plan last year have been added along with incentives. Middle School campus is 100% highly qualified. In order to eliminate students from being pulled out of core classes to receive extra help with the STAAR reading and math testing a class has been added to the schedule that will be used especially for that purpose.

## **Brady Elementary**

Kelley Hirt, Principal, stated one of the focuses on the campus will be refining social skills training. They will be more aggressive on improving attendance. A mentoring program will be initiated that will involve parent/community members who will be used to develop a mentoring relationship with the students. Areas of concern that will be addressed are the at-risk and the Hispanic student's state testing performance. All teachers on the campus are highly qualified.

A motion was made by Mr. Keese, seconded by Ms. Pearce and carried 7-0 to approve the District and Campus Improvement Plans as presented by Mr. Clawson.

## Policy FFC Local Contact Change

A motion was made by Mr. Keese, seconded by Ms. Pearce and carried 7-0 to change the contact information in Policy FFC Local from Blanca Lafuente-Martinez to Judy Fincher.

A motion was made by Mr. Raybion, seconded by Ms. Trull and carried 7-0 to change the contact information n Policy FB Local from Ann Moore to Hollis Moore.

# Elect TASA/TASB Delegate

A motion was made by Mr. Keese, seconded by Ms. Trull and carried 7-0 to elect Jason Jacoby as the TASA/TASB Delegate.

A motion was made by Ms. Pearce, seconded by Mr. Keese and carried 7-0 to elect Robert Duus as the TASA/TASB Alternate Delegate.

# Water/Sewer Addendum from CTO

Mr. Clawson explained that at this time all facilities at the vacant high school campus share the same water/sewer system. Central Texas Opportunities are now leasing the FCS building and the counselor's building; therefore in order to be fair with the expense of the water/sewer system CTO has agreed to pay to Brady ISD \$110 per month for their share in the expense. The figure was derived from an average of the years 2010, 2011 and through June of 2012 monthly expenses. A motion was made by Mr. Keese, seconded by Ms. Keith and carried 7-0 to approve the

Lease Addendum for water/sewer payments by CTO in the amount of \$110.00 per month and will continue to pay such expense until such time when the water and sewer for the leased space by CTO is separated from the multiple facilities.

## Adopt Proposed M&O/I&S Tax Rate for 2012-2013

Mr. Clawson gave a brief overview of the proposed budget for the 2012-2013 school year explaining some of the changes that were made since the last budget workshop. The proposed budget now stands at \$10,392.990. Barbara Landry, Business Manager, answered questions regarding the proposed budget. Ms. Landry explained the proposed M&O rate cannot exceed \$1.04 and the proposed I&S rate cannot exceed \$0.384266. The board can however adopt lower tax rates if desired. A motion was made by Mr. Keese, seconded by Mr. Raybion and carried 7-0 to adopt the proposed Maintenance & Operation tax rate of \$1.04 and the proposed Sinking & Interest Rate of \$0.384266 for a total tax rate of \$1.4242.

# Call a Special Meeting Friday, August 31, 2012

A motion was made by Mr. Raybion, seconded by Mr. Keese and carried 7-0 to call for a special meeting to be held Friday, August 31, 2012 beginning at 12:00 noon at the Administration Office Board Room to adopt the 2012-2013 budget and tax rates.

The PATS organization will be providing a meal for the staff on Wednesday at 8:00 a.m. The organization will also be providing school supplies for each student. Thursday Grade 6 students may pick up their schedule beginning at 5:30 and Grades 7 and 8 may pick up their schedules beginning at 6:30.

### High School
