ACTION ITEMS

Approve Minutes A motion was made by Mr. Hernandez, seconded by Mr. Lafuente and carried 5-0 to approve the minutes from the September 19, 2016 regular

meeting after making the following correction. Under "new

business/discussion items" TASB Update 106 change the word "effect" to

"affect". Ms. Locklear abstained from voting on the motion.

Quarterly Investment Report

A motion was made by Ms. Trull, seconded by Ms. Locklear and carried 6-0 to approve the quarterly investment report ending September 31, 2016 as presented by Barbara Landry, Business Manager.

Budget Amendments A motion was made by Ms. Locklear, seconded by Ms. Keith and carried 6-0 to approve the following budget amendments.

To amend the 2016-2017 Operating budget as follows:

To record a donation from Brady Band Boosters for \$2,500 to repair

Adopt Resolution-Additional Designation of Fund Balance 2015-2016 School Year A motion was made by Ms. Locklear, seconded by Mr. Hernandez and carried 6-0 that an additional \$355,000 be committed to Designated Fund Balance with \$75,000 for equipment and \$280,000 for salaries making the total commitment for Designated Fund Balance for the 2015-2016 school year \$455,000.

Adopt TASB Update 106

A motion was made by Ms. Trull, seconded by Ms. Keith and carried 6-0 to adopt the TASB Update 106 affecting EHBAF Local policy-Special Education-Video/Audio Monitoring.

Sale of 2.417-Acre Tract of Land Near BE

Mr. Clawson explained that in order to sell the parcel of land the district must go through a sealed bid process. The resolution enables the superintendent to advertise and oversee the sale of the tract of land. Mr. Clawson stated the plan would be to begin advertising and present the bids at the November 21 meeting. A motion was made by Mr. Lafuente, seconded by Mr. Hernandez and carried 6-0 to adopt the resolution to sell the 2.417-acre tract of land adjacent to and south of Brady Elementary School per recommendation by Mr. Clawson.

Lease Agreement w/McCulloch Co.-Admin. Offices at 1000 Wall St. Mr. Clawson explained the Administration Offices that are at 1000 Wall Street have been vacant. Judge Danny Neal approached him regarding a lease agreement with McCulloch County and moving the Juvenile Probation Offices into the building. The lease agreement would be for (5) years beginning November 1, 2016 with the option to renew year to year. The rental amount would be \$100 per month. McCulloch County would be responsible for all maintenance and upkeep of the building and liability insurance. The District will pay for all utilities during the term of the lease. A motion was made by Mr. Hernandez, seconded by Ms. Locklear and carried 5-0 to approve the lease agreement with McCulloch County for the administration offices located at 1000 Wall Street with the beginning date of November 1, 2016. Ms. Trull abstained from voting on the motion.

Set Date for Team Building

A motion was made by Mr. Hernandez, seconded by Mr. Lafuente and carried 6-0 to set the Team Building Training on Wednesday, November 2 beginning at 5:00 p.m. in the Administration Office Board Room.

2016-17 District & Campus Improvement Plans

Hollis Moore explained the District Improvement Plan is basically a summary of the campus improvement plans. The improvement plans are based on numerous areas including STAAR scores, campus meetings, campus desegregation, etc. He emphasized the district and each campus improvement plan is a living document which means it changes numerous times throughout the year to meet the needs of the campuses. A question and answer session was held. Upon the end of the session a motion was made by Ms. Trull, seconded by Ms. Keith and carried 5-1 to postpone approving the district and campus improvement plans until the November 21, 2016 regular board meeting. Mr. Hernandez opposed the motion.
