## Call Special **Meeting Regarding** the Windfarm

Mr. Clawson spoke with Sara Leon of Powell & Leon regarding the windfarm project. Ms. Leon stated all paperwork is in and has been approved by the Comptroller's Office. The project now needs a final approval from all entities in order for the project to begin. The meeting needs to take place before March 28. A motion was made by Mr. Probst, seconded by Ms. Keith and carried 6-0 to schedule a special meeting for Tuesday, March 22 beginning at 4:00 p.m.

## **Flooring Bids for** MS Library & 7 **BE Classrooms**

Mr. Clawson explained the new flooring will be a summer project. Brady Floors turned in a bid of \$11,138 for the MS Library and \$27,628.54 for the 7 BE classrooms. Discussion was held to see if it might benefit the district to seek bids from surrounding towns. A motion was made by Mr. Probst, seconded by Mr. Kitchens and carried 5-1 to table the acceptance of a bid until further bids are received. Ms. Keith opposed the motion.

# **Materials Allotment & TEKS Certification for** 2016-2017

Adopt Instructional Eric Bierman, HS Principal, explained in order to receive TEA funds to purchase textbooks for the next year a certification form must be submitted stating the funds will be used for instructional materials with grade level and subject areas. The district purchases only the materials that are state approved. A motion was made by Mr. Lafuente, seconded by Ms. Keith and carried 6-0 to adopt the Instructional Materials Allotment & TEKS Certification for the 2016-2017 school year.

## **Adjust Spring** Calendar

Mr. Clawson explained the new legislature now states students must attend school for a required 75,600 minutes. This year the students will attend over the required minutes according to the current school calendar. The minute's overage is approximately equivalent to 4.9 days. Mr. Clawson recommended adjusting the spring calendar to include three additional student holidays. These three days will be for students only. Staff must still be present for staff development. The three days asked for is Friday, April 1, Friday, April 15, and Friday, May 20. Administrators present voiced their need for the days to be used as student holidays. A motion was made by Mr. Probst, seconded by Ms. Keith and carried 6-0 to adjust the Spring Calendar implementing April 1, April 15, and May 20 as three additional student holidays/staff development days per recommendation by Mr. Clawson.

#### **Principals**

#### **High School**

Eric Bierman, Principal, reported the FCCLA teams competed in Waco with 8 out of 10 teams advancing to the state competition. Fish/Parent Night had 77% of student parents attending. Four girls have qualified for state in powerlifting. Citizens Bee competition was held in San Angelo with one Brady student representing Region 15 at the state competition. One Act Play will compete in District March 23 in Bangs. FFA students have been competing well in various events.

#### **Middle School**

Shona Moore, Principal, stated tutorials continue. Grade 8 students will be attending the Bob Bullock Museum and IMAX in Austin. Cheer tryouts will be Friday. STAAR testing begins March 29. Robotics has two teams advancing to the state competition. Ms. Moore was notified that the third team was selected to compete at state as the "wild card" team. Fundraisers are being held to curb medical expenses for a MS student who has developed health issues.

#### **Brady Elementary**

LaVonta Harper, Administrator, reported 36 ESL students participate in after school tutoring. The Bulldog Academy continues after school which helps those students with homework to receive extra help. Staff continues to work on campus needs assessment. PTO hosted a fundraiser for the end of year book fair. Open house for Texas Public School Week on Thursday until 5:30 p.m. Beginning at 5:30 Grade 5 students will host a fundraiser "Night of the Stars". All proceeds will go towards the expense of the Science Camp.

#### **Food Service**

Sheri Wheeler, Director, reported the audit is completed and there were no findings which is very unusual. She thanked her staff at the MS campus and complimented Adriana Flores, Admin. Asst. for all her time and effort in preparing for the audit. Tomorrow the theme in the cafeterias is "baseball". Coaches will be serving in the serving lines. April 22 is Earth Day and the tower gardens will be open for tours.

#### **Athletics**

Chuck Lipsey, Director, gave an update on all spring sports. Girls powerlifting team placed second overall at regionals and 4 lifters will be advancing to state. The boys will compete this weekend at the regional meet. He announced the girls and boys All District basketball honors.

The golf teams are participating well in the tournaments. Softball is 3-3 and baseball 4-4 for the season. Tennis and track have attended several meets. He gave a review of the MS H.O.T. relay results. Two football players received all-state honors. The 2016 football schedule is complete.
