Accept Quarterly Investment Report Mr. Cook moved to accept the Quarterly Investment Report ending December 31, 2020 as presented by Ms. Landry, seconded by Mr. Booker

and the motion carried 7-0.

Accept Resolution For District of Innovation to Begin Process Dr. Martinez explained that should BISD become a District of Innovation it would allow the district to have more local control than what it does now. The resolution states the board allows Dr. Martinez to begin the initial process by visiting with campus employees. The process can be terminated at any time.

He continued to explain being a District of Innovation covers a number of areas. There are three areas he would like to focus on. The first is the district calendar. Right now, state law requires the district to begin school

the fourth Monday of August. Should we become a DOI it would enable us to begin school earlier which would be better for testing and also even out the number of days in both semesters.

The second area of focus would be CTE teacher certifications. Currently the district must hire certified TEA teachers for all CTE classes offered. Being a DOI would change certification requirements. He emphasized BISD would still require TEA certifications for all core teachers and those in the elementary. The only certifications he would like to change is for CTE teachers. He explained these teachers are difficult to find. Also, currently should we lose a CTE teacher it could delay or even terminate the program for those students participating should a TEA certified teacher not be found. Even if the district would become a DOI, the district would first search for a TEA certified teacher. Should one not be found the district could then utilize community members who have the experience needed for the position without having to receive a TEA certification or an employee with the experience but is outside of their certification. Dr. Martinez explained this would also help at the Middle School where Robotics is being offered currently as an elective which could become a CTE class under the DOI.

The third area would be employee contracts. Currently by state law when the district hires a new teacher, they automatically receive a probationary contract. The second year they would receive a term contract if they have taught five consecutive years out of eight. Being a DOI it would allow the district to retain the new hire for three probationary years instead of the one.

Should the board choose to approve the resolution tonight to begin the process Dr. Martinez would have 30 days which would be the next board meeting to give a report indicating the support or lack of from the campuses. If there is sufficient support from the campuses the board can elect to continue the process. A DOI committee would be formed along with the use of the Campus and District Site Base Committees to create the plan. The plan would be for a period of five years in which no changes can be made during the five years without board approval. Again, Dr. Martinez stressed the fact that the district will hire only TEA certified teachers for core classes and elementary positions. Certifications will affect CTE teachers only and in the spring those positions will be posted in search of certified teachers.

Ms. Locklear moved to adopt the resolution to consider designation as District of Innovation as presented by Dr. Martinez, seconded by Mr. Raybion and the motion carried 7-0.
