The Board of Trustees for the Brady Independent School District met in regular session at 6:00 p.m. on Monday, March 15, 2021, in the school administration building. The meeting was called to order by President Eric Bierman at 6:00 p.m.

ACTION ITEMS

Approve Minutes Mr. Williams moved to accept the minutes from the February 22, 2021

regular meeting with the correction of the spelling of Brady in the budget amendments and the minutes from the March 1, 2021 special meeting,

seconded by Mr. Cook and the motion carried 6-0.

Budget Amendments With no budget amendments presented Mr. Booker moved to accept the notification of no change to the budget, seconded by Mr. Williams and the

motion carried 6-0.

Certification of Unopposed Candidates for May 1, 2021 Mr. Cook moved to accept the Certification of Unopposed Candidates for the May 1, 2021 General Election as follows, seconded by Mr. Booker and

the motion carried 6-0.

Order of Cancellation for May 1, 2021 General Election Ms. Locklear moved to accept the Order of Cancellation for SMD 1, 5, and 7 for the May 1, 2021 General Election and declare unopposed candidates elected as listed above, seconded by Mr. Cook and the motion carried 6-0.

Resolution to Extend Depository Contract for 9-1-21 to 8-31-23 Hector Martinez, Superintendent, explained the district has the option to extend the current Depository Contract for Funds with Brady National Bank for an additional two years. After researching interest rates at other institutions it was found that the rates are all low and around the same rate. Due to a conflict of interest, Mr. Hernandez asked that Mr. Williams and Mr. Cook abstain from any discussion. Ms. Locklear asked if the rates are variable or constant in which Dr. Martinez stated they are variable. Barbara Landry, Business Manager, reported Brady National Bank is offering the district the highest rate at this time. Mr. Williams offered the option that the district may also purchase CDs at a higher rate as well. Mr. Booker moved to adopt the resolution to extend the Depository Contract for Funds for two additional years with Brady National Bank beginning

September 1, 2021 through August 31, 2023, seconded by Ms. Locklear and the motion carried 4-0. Mr. Williams and Mr. Cook abstained from the vote.

Approve Missed Feb. 12 and Feb. 15-19, 2021

Dr. Martinez explained the days listed on the Missed School Days Waiver School Days Waiver-being Feb. 12 and Feb. 15-19 are when the district was closed due to the bad weather. He must submit an application to the state in order to have the days waived and not count against the district. However, in order to submit the waiver the board must vote to approve for him to proceed with the application. Mr. Williams moved to give permission to Dr. Martinez to proceed with the application for the Missed School Days Waiver for Feb. 12 and Feb. 15-19, seconded by Mr. Cook and the motion carried 6-0.

DISCUSSION ITEMS

District COVID-19 Response Plan

Dr. Martinez discussed the wearing of masks in the district. Governor Abbott has lifted the mask requirement for the state but gave no direction for schools. He gave the authority to TEA to govern the schools. Under the guidance of TEA all schools are to continue wearing masks for the remainder of the school year. The only way a district may modify or eliminate the guideline of the masks is by school board approval. Dr. Martinez gave an overview of the COVID-19 statistics for the campuses. He realizes people are tired of wearing the masks, but they do help to keep the number of guarantines at a low. He reminded the board that even without the mask requirement the quarantine protocol is still in place. Dr. Martinez continued that the district is coordinating with the hospital to get educators vaccinated. Mr. Cook asked if the staff has been given an opportunity to voice their opinion. Dr. Martinez stated he would be happy to send out a survey if that would help the board make a decision. Mr. Cook feels it will be a split decision on the survey and felt the district should offer the option of wearing a mask instead of making it a requirement as long as it doesn't affect the teachers. Dr. Martinez stated students with medical issues may be exempt with the proper doctor documentation. Mr. Bierman spoke with several high school students whose comment was they are used to them and should keep the requirement in place until the end of the school year. Mr. Bierman's opinion was also the same and should the cases continue to decline the board may want to relook at the mask requirement and possibly lift the requirement. Dr. Martinez explained he is not opposed to coming back in April to discuss the mask requirement again. He continues to be in contact with Dr. Vickers, Health Authority. Ms. Locklear also agreed the board should revisit the issue in April due to the fact that people are coming back from traveling during Spring Break. Mr. Williams voiced he felt the board was discussing both sides of the issue and should continue doing so.
