2021 Attorney Agreement-Chapter 313

Mr. Cook moved to enter into the 2021 Engagement Agreement with Powell Law Group as the district's attorney and finance consultant under Chapter 313 of the Texas Tax Code per recommendation by Hector Martinez, Superintendent, seconded by Ms. Locklear and the motion

carried 4-0.

Approve Retainer Agreement for Legal Services

Dr. Martinez recommended the district retain Walsh Gallegos for legal services for the upcoming year. The firm charges a retainer fee of \$1,000 per year and they have done an outstanding job for the district this past year. Ms. Locklear moved to approve the retainer agreement for legal services with Walsh Gallegos per recommendation by Dr. Martinez, seconded by Mr. Cook and the motion carried 4-0.

Increase Food Service Meal Prices for 21-22

Dr. Martinez reported the changes in the meal prices for 21-22 based upon USDA guidelines. All students will receive one free breakfast with an additional breakfast costing \$2.10. All students will receive one free lunch per day. The only change to the adult meals is the lunch which will increase from \$4 to \$4.25. Mr. Booker moved to approve the increase in the Food Service meal prices for 21-22 school year per recommendation by Dr. Martinez, seconded by Mr. Cook and the motion carried 4-0.

McCulloch Co. Appraisal Dist. 2022 Proposed Budget Dr. Martinez stated overall there is not a large increase in any area of the proposed budget. Because the district is a taxing entity the board is given the opportunity to review the proposed budget each year.

First Reading-TASB Update 117 Dr. Martinez explained the TASB update consists of both legal and local policies. The local policies are created for each individual district therefore the district can make any changes to local policy at any time. State Assessment Update (STAAR)

Dr. Martinez presented a chart in which administrators can track classes of students from year to year evaluating how each class performed in the STAAR testing. This will also help administrators see what grade level might be struggling in specific areas. Richard Sweaney, Asst. Superintendent, gave a comparison of the district's STAAR testing results to the state and region average percentages of students that "approached grade level, met grade level, or exceeded grade level" in each testing subject and grade. The district was above the state and region percentages in the majority of subjects and grade levels.
