One of the main concerns of the board was the old fieldhouse/locker rooms/gym by the stadium. Dr. Martinez had contacted Waldrop Construction and Clifton Stuckey, architect, to look at the buildings and create ideas as to the remodeling or building of a new facility. The major concern is updating the present building to meet ADA compliance. Because of the expense involved an architect must be used. Therefore, Dr. Martinez has asked Mr. Stuckey to draw up plans for renovation and for the construction of a simple building.

#### Curriculum
